It is bring to your kind notice that the second wave of Covid,19 is spreading very past. It is reported that severe pandemic situation is prevailed in all the SSAs. Due to sever position good number of officials are loosing their lives. In circle office about 15 staff members were affected the desease. Staff are afraidng to come to office. One GM already lost his life because of this severe situation. With reference to the cited above, corporate office has issued instructions to all the circle heads to take a decision in this regard to minimise staff in the office. ie to bring 50% staff of below E5 levels on the basis of alternative days.

Vide CO,ND orders BSNL CO-A/11(11)/2/2020-ESTAB, Dated 18-04-2021 issued orders in respect of corporate office for implementation of order dated 16-4-21. Telangana circle office also issued instructions in the same manner. In the same situation during March-April, 2020 some tangent steps were taken by the then administration. In this connection as recognised union NFTE-BSNL and representative union of staff we request to take the following action as need of the hour.

1. Issue instructions to all SSAs including circle office to bring 50% of staff as alternative days basis up to the situation come to an average stage.
2. All Adhar points in the CSCs and CSCs manned by us may be closed up 14 days.
3. Supply of Face shield masks may be ensured to all public moving staff.
4. Immediate address a letter to the cheif secretary to provide vaccination to our staff at our work places by deputing medical and health workers as done in case of banks. As telecom (BSNL) being a essential services. If it is not possible for them, particular point may be ear marked exclusively for BSNL staff in every urban station, so that our staff may get vaccination without any hard ship.
5. Ensure sanitisers and masks made available to the staff by the concerned authorities in the field.

This union may ever grateful to you Sir, if you could kind enough to issues instructions to all concerned.
