Sub: - Agenda points submitted by NFTE-BSNL AP Circle union for the Formal meeting- reg.

It is to intimate that the 5th CCM held on Dt 06-03-2021 and after discussions in the capacity of the Chairman of the CCM, you have agreed to conduct the next meeting in the month of June-2021. But un-fortunately the said CCM not took place even after submission of the agenda points by the staff side. So, some of the important issues which alarming are submitted herewith for discussions in the formal meeting for early action please.

Therefore, you are requested to kindly arrange the formal meeting with our union for discussions on the following issues please.

1. Proper maintenance of the SANITARY WORKS in all work places of AP circle in this situation .i.e. COVID-19 third wave - Reg.

It has brought to our notice that in many offices and Exchanges the sanitary works are very poor and the concern officers are expressing their inability to fulfill the same as funds are not available. So staff are facing much inconvenience and afraid of their health.

Hence, we request you to kindly look into the issue personally and allot the required funds all field units.

2. Efforts to process the compassionate ground Appointments which finalized by the circle HPC -Reg.

The ban on CGA for three years from 1-4-2018 has completed and further review has to be taken by the corporate office. But no initiation found from BSNL CO New Delhi.

In this connection, we request the CGMT may take needful steps with corporate office to process the pending CGA cases under humanitarian grounds please.

3. Review on organizational Restructuring of man power proposals of AP circle - Request & suggestions submitted by the staff side vide our union letter dated 06-01-2022

4. Nomination of Nodal officers for processing the cases of SPS for BSNL Direct Rect. - Reg.

The CO-ND Vide letter No BSNLCO-A/12(12)/4/202-ESTAB Dt.14-01-2022 circulated the guidelines regarding processing the cases of superannuation pension scheme for BSNL direct recruits . Where, it was stated that a nodal officer may be designated to process the claim forms to BSNL CO.

Hence we request to kindly nominate a Nodal officer in this regard and arrange to collect the claim forms from the units as many employees are retired under superannuation as well as VRS-19 and they are not aware of this policy.

5. Efforts for removal of discrepancy in EPS/EPF of Direct rect. During sep/2014 batch of JE Cadre - Reg.

Please refer our union memorandum on the subject Dt. 20-12-2021.

6. Serious efforts needed from circle management for processing the Empanelled hospitals in field units -request- Reg.

Due to non- Renewals of Empanelled hospitals in District head quarters, our employees are suffering very much for indoor treatments of ailments of self and families. The hospital authorities are not showing interest for renewals stating that bills payments are delaying and some pending bills not settled.

Hence, we request the circle management pursue this seriously and issue directions to the BA managements to take the needful steps to convenience the hospital authorities for renewals under the welfare of our employees please.
